Emergency Economic Measures; 230 trillion yen (approximately 13.5 trillion DKK) (40% of Japan's GDP)

Measures in support of business

- Expanding special measures on the Employment Adjustment Subsidies
- Real interest-free unsecured loans
- Improved loan conditions: allowing recurring debts to be refinanced as interest free loans
- Deferment of the payments of national taxes and social security premiums without collateral and penalties (amounting to ¥26 trillion (approx. 1.6trillion DKK))) etc.

Cash Payments

- Cash payment of 100,000 JPY (approx. 6,250 DKK) each to individuals in need
- Cash payments of 2 million JPY(125,000 DKK) each to micro-, small-, and medium-sized business and 1 million JPY(62,500 DKK) each to individual business owners

Frameworks for Entry into Japan

✓ Residence Track

This framework allows cross border travelers to enter, exceptionally, Japan or the other country/region, but requires them to stay at home for 14 days or designated locations. This framework is intended mainly for long-term residents by dispatch or rotation within business personnel.



Frameworks for Entry into Japan

✓ Business Track

This framework allows cross-border travelers to enter, exceptionally, Japan or its counterpart country/region. Furthermore, this framework <u>enables limited business activities during the 14-day stay at home period</u> (partially relaxes restrictions on such activities), immediately after arrival at those countries/regions or Japan, on condition that travelers accept additional quarantine measures such as submission of "Schedule of Activities in Japan"(Note). This framework is intended mainly for <u>short-term business travelers</u>. (Note: Business activities must be limited to the necessary minimum, such as round-trip travel between home and the office, not using public transportation and avoiding contact with random people or crowds.)

2. What and how we should act together? ①Development of drugs and vaccines

✓ Emergency grant aid to deliver the anti-viral medicine "Avigan"

- On 7th April, the Government of Japan decided to provide Emergency Grant Aid of 1 million US dollars to the countries with COVID-19 patients.
- This will provide "Avigan" tablets as requested by beneficiary governments through UNOPS.
- FUJIFILM Diosynth Biotechnologies, HILLERØD teams with COVID-19 Therapeutics Accelerator to reserve manufacturing capacity and provide technical expertise to deliver future COVID 19 therapies
 - FUJIFILM will work with a selected pharmaceutical partner in supporting the swift manufacture and dedicated supply for patients with COVID-19 in lower-income countries.
 - Under the agreement, production volumes are secured for 2021 with options for a number of years thereafter.

✓ AGC to Manufacture COVID-19 Vaccine for AdaptVac

- AGC Biologics (Headquarters: US) is partnering with Denmark-based AdaptVac to manufacture a candidate COVID-19 vaccine.






✓ MHI Vestas Offshore Wind will supply wind turbines in Akita Noshiro in Japan






- Hydrogen contributes to diversifying the structures of energy supply and also has the potential to become a dynamo to achieve dramatic low carbonization in society.
